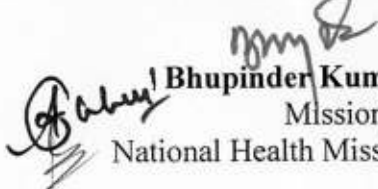
As per the approval/sanction conveyed by the Ministry of Health & Family Welfare, Govt. of India to deal with the existing pandemic of COVID-19, sanction is hereby accorded to release of Grants-in-Aid of **Rs.6,94,585/- (Rupees Six Lac Ninety Four Thousand Five Hundred Eighty Five only)** under India COVID-19 Emergency Response and Health System Strengthening Preparedness Package under NHM for *Mobility Support (FMR Code: B.31.5)* during the financial year 2020-21.

Accordingly, the above sanctioned GIA is transferred into the official Bank A/c No. **SG-0404040500008648** of Divisional Nodal Officer, Kashmir maintained Jammu & Kashmir Bank Ltd, Old Secretariat, Srinagar.

**The Grant-in-Aid is subject to the following conditions:**

1. That the sanctioned funds are to be utilized for *Mobility Support. (in reference to indicative list of activities annexed herewith)* after observing all codal formalities required under rules and guidelines issued by the MoH&FW, GoI.
2. That the Divisional Office shall accept the funds on PFMS portal after confirming the same from its bank account and subsequently release funds to the concerned through the said portal/e-transfer under intimation to the State Health Society, NHM, J&K and also ensure expenditure be uploaded on PFMS Portal.
3. That the monthly Statement of Expenditure and Utilization Certificates (*in form GFR 12C*) are to be sent to the State Health Society.
4. That the proper record of Bank Column Cash Book, Ledger, Assets Register and other relevant records are to be maintained for inspection of any visiting team from Central/State Government.
5. That the accounts of the grantee/organization shall be open to the inspection by the sanctioning authority and audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by Principal Accounts Officer of the Ministry of Health & Family Welfare, GoI, whenever the grantee/Society is called upon to do so.
