**Sub: Release of GIA under Health System Strengthening for Training of Trainers/DPRs under HBYC under NHM during the financial year 2020-21 (FMR Code: 3.1.2.8)**

As per the approval conveyed by the Ministry of Health & Family Welfare, GoI in the NHM SPIP for the financial year 2020-21 for J&K UT and subsequently approved by the Chairman, Executive Committee, State Health Society, NHM, J&K sanction is hereby accorded to release of Grants-in-Aid of **Rs.1,25,900/- (Rupees One Lac Twenty Five Thousand Nine Hundred only)** in favour of Divisional Nodal Officer, Jammu and **Rs.2,49,200/- (Rupees Two Lac Forty Nine Thousand Two Hundred only)** in favour of Divisional Nodal Officer, Kashmir under Health System Strengthening for Training of Trainers/DPRs of 12 new Districts of Jammu/Kashmir division under Home Based Care for Young Child during the financial year 2020-21 under NHM.

**[ The Grant-in-Aid is subject to the following conditions:**

1. That the above sanctioned GIA is exclusively meant for Training of Trainers/DPRs of 12 new Districts of Jammu/Kashmir division under Home Based Care for Young Child during the financial year 2020-21 under NHM.
2. That the funds are to be utilized strictly *as per the estimated budget sheet* and guidelines issued by the MoH&FW, GoI and after observing all codal formalities required under rules (*strictly no cash payments*).
3. That the Statement of Expenditure and Utilization Certificates are to be sent to the State Health Society immediately after completion of training.
4. That the proper record of Bank Column Cash Book, Ledger, Assets and other relevant record are to be maintained for check of any visiting team Central/State Govt.

5. That the accounts of the grantee shall be open to the inspection by the sanctioning authority and audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by Principal Accounts Office of the Ministry of Health & Family Welfare, Government of India, whenever the society is called upon to do so.
