Sub: Release of Grants-in-Aid for Remuneration of Manpower engaged under India COVID-19 Emergency Response and Health System Strengthening Preparedness Package (ECRP-II) under NHM for the financial year 2021-22. (FMR Code: S.3 "Enhancement of Human Resource for Health").

Madam/Sir,

As per the Administrative approval conveyed by the Ministry of Health & Family Welfare, Govt. of India to deal with the existing pandemic of COVID-19 and subsequently approved by Chairman, Executive Committee, State Health Society, NHM, J&K, sanction is hereby accorded to the release of Grant-in-Aid of **Rs. 563.34 lacs** (Rupees Five Crores Sixty Three Lacs Thirty Four Thousand only) under India COVID-19 Emergency Response and Health System Strengthening Preparedness Package (ECRP-II) on account of remuneration of already engaged manpower under COVID-19 in various health institutions for a period of 3 months w.e.f. 

Accordingly, the sanctioned funds are hereby transferred through e-transfer into the official Bank A/cs of your Implementing Agency/District Health Society.

The Grants-in-Aid is sanctioned subject to the following conditions:

1. That the above sanctioned funds are to be utilized exclusively for Remuneration of manpower engaged for management of COVID-19, strictly as per the rates, terms and conditions conveyed time to time for 3 months under ECRP-II and after observing all codal formalities required under rules and guidelines of MOHFW, GoI.
2. That contractual manpower is to be continued further only after appraising their performance and seeking approval from the competent authority.
3. That no diversion/reappropriation of funds is permissible without approval of the Competent Authority.
4. That as per the directions of GoI & Aadhaar Act 2016, Aadhaar Number being mandatory to receive any social benefits. The health institutions shall ensure 100% seeding of all contractual staff engaged under NHM.
5. That the Physical/Financial achievements are to be sent to the State Health Society on regular basis.
6. That the funds shall be utilized to fill up the gaps to deal with COVID-19 pandemic and also ensure that there may not be duplication of similar activities from the other source.
7. That the accounts of the grantee shall be open to inspection by the sanctioning authority and audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by Principal Accounts Officer of the Ministry of Health & Family Welfare, Government of India, whenever the society is called upon to do so.
