

2. That a separate assets register for the programme is maintained at the level of each facility under seal & signatures of the Head of the institution.
3. That all purchases required to be made are affected from the valid and approved rate contract of the concerned purchase committee of the department.
4. That the funds are utilized after observing all codal formalities required under rules and guidelines of MOH&FW, GOI, which is available on the website i.e. [www.jknrhm.com](http://www.jknrhm.com) and [www.jkhealth.org](http://www.jkhealth.org)
5. That monthly Statement of Expenditure and Utilization Certificate is sent to the SHS regularly.
6. The account of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by Principal Accounts Officer of the ministry of the Health & Family Welfare, GOI.
