## **TERMS AND CONDITIONS:**

- 1. Candidate should be permanent resident of J&K State.
- 2. Candidate should have excellent communication and presentation skills in English and local language, and must be conversant with computers especially in MS Office, etc.
- 3. Candidate should have familiarity with socio-cultural and socio-economic conditions of the State.
- 4. Candidate should be dedicated, hardworking and willing for extensive touring across the State.
- 5. In addition to concerned District, candidate may opt for two additional Districts where he/she is willing to serve. Selection of candidate will be as per the District-wise merit out of eligible candidates. However, in case of non-availability of suitable eligible candidate from the concerned District, State Health Society will consider the candidate on the basis of merit cum preference opted by him/her.
- 6. Merit of candidates, who have obtained degrees from Foreign Universities having grading system, shall be calculated on the pattern of Jammu & Kashmir Public Service Commission.
- 7. Hiring will be purely on contractual basis. Initial contract for hiring shall be upto 31<sup>st</sup> March 2018, and further yearly extension will be subject to satisfactory performance of the candidate/ approval of the post by the Ministry of Health & Family Welfare, Govt. of India.
