1. That the funds are exclusively meant for Procurement of Equipment i.e. Paediatric Ventilators, Bubble CPAP Machine & Transport Incubators for SNCU/NICUs under Roadmap for Reducing IMR in the State during the financial year 2019-20 under NHM. In case of any query, please contact Programme Manager, Child Health/RBSK, SHS, NHM, J&K.
2. That the Directorate shall accept the funds on PFMS portal after confirming the same from its bank account and subsequently release funds to the Districts/Implementing/Executive Agencies immediately through the said portal/e-transfer under intimation to the State Health Society, NHM, J&K and also ensure expenditure be uploaded on PFMS Portal.
3. **That the work shall be executed strictly as per the estimates/drawings/Plan technically approved by the competent authority.**
4. **That the Administrative Approval/Technical sanction of the work is obtained from the competent authority before execution of work and booking of expenditure.**
5. **That the work shall be restricted and completed within the administratively approved cost and there shall be no repetition of work.**
6. **That no diversion /re-appropriation of funds shall be made without approval of competent authority.**
7. That the funds are to be utilized after observing all codal formalities required under rules and as per guidelines issued by the MoH&FW, GoI .
8. That the Statement of Expenditure and Utilization Certificates are to be sent to the State Health Society alongwith certification of establishment of NICU.
9. That all the infrastructure/equipment supported under NHM should prominently carry NHM Logo in English, Hindi and regional languages.
