## Corrigendum

In reference to the concern(s) of intended participant(s) during Pre-EoI meeting held on 06<sup>th</sup> April 2023, with respect to this office Notice inviting online Expression of Interest (EoI) from the Agency(ies)/ Service Provider(s) for implementation of web/ mobile based GPS bio-metric attendance application in healthcare facilities/ administrative offices under Health Department in Jammu and Kashmir, following modification(s) shall henceforth form Integral Part of above-mentioned Notice and shall accordingly be construed alongwith other Terms & Conditions -

- 1. In view of timelines set forth towards implementation of this ambitious Project for NHM manpower working in healthcare facility(ies)/ Administrative Office(s) across J&K, corresponding technical, financial & other capabilities required for successful implementation, formally constituted 'Consortium' of Not more than three (3) member(s), including one Lead Partner and Two (3) other Member(s), duly and specifically constituted for the purpose, is allowed to participate subject to the condition that all Consortium Partner(s) will commit to the Scope of Work alongwith defined Roles, Responsibilities, Rights & Liabilities and shall be answerable for the performance of obligations under this Selection Process and consequent Rate Contract, Jointly as well as Severely. Any change/ modification in Consortium during the currency of intended contract period shall not be allowed, except in case of any extreme & unavoidable exigency and only after seeking explicit approval from the Mission Director, NHM, J&K, whose decision in the matter shall be final and binding on all the concerned parties. Any violation of these condition(s) may lead to debarring all the members from participation in all the future procurement processes under NHM in J&K for a period of Ten (10) years. This will be in addition to other courses of action, including forfeiture of EMD/ Performance Guarantee and other payments, etc. available with NHM under this Process.
- 2. Similarly, Sole Authorized Distributor(s)/ Vendor(s) of Original Software/ Application Developer(s) may also submit response to the EoI subject to the condition(s) that the Original Software/ Application Developer(s) has issued authorization in favour of such Sole Authorized Distributor(s)/ Vendor(s) to submit response to the EoI, alongwith its commitment to render all the requisite Technical Support, as & when required, throughout the Contract Period, including extended period, if any. It shall also be ensured that an Original Software/ Application Developer(s) may either participate directly, or through its Sole Authorized Distributor(s)/ Vendor(s). Any violation of these condition(s) may lead to debarring not only such authorized Distributor(s)/ Vendor(s), but also the Original Software/ Application Developer(s) from participation in all the future procurement processes under NHM in J&K for a period of Ten (10) years. This will be in addition to other courses of action, including forfeiture of EMD/ Performance Guarantee and other payments, etc. available with NHM under this Process.
- 3. Clause (4) of Eligibility Criteria stipulated under Section III shall now be read as "Intended Participants(s) should have deployed similar Online Attendance Application, in at least One (1) Central/State/UT Govt. Organizations/Public Sector Undertakings/Corporations/Autonomous Bodies/Any Reputed Company (Limited/ Private Limited) having at least 1000 employees, during preceding 7 Years ended on 31st March 2023. However, it shall be without any

corresponding relaxation in Evaluation of EoIs, as per criteria stipulated under Clause (IV) of Section - IV.

4. Except above-mentioned modification(s), all other Terms & Conditions, alongwith Timelines, shall remain the same.
