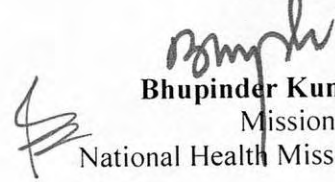
The Grants-in-Aid is sanctioned subject to the following conditions:

1. That the above sanctioned GIA is exclusively meant for providing the medical facilities enroute Shri Amarnath Ji Yatra 2020 and to be utilized strictly for the activities projected in the proposal of your office and after observing all codal formalities as contained in the J&K Financial Codes.
2. That no diversion of funds is permissible without approval of State Health Society.
3. That the Directorate shall accept the funds on PFMS portal after confirming the same from its bank account and subsequently release funds to the concerned units/health institution immediately through the same portal/e-transfer under intimation to the State Health Society, NHM, J&K and also ensure that all the expenditure are to be uploaded on PFMS portal.
4. That the procurement of drugs/structures/equipment is to be made through J&K Medical Supplies Corporation Ltd or as per the instructions conveyed by the Administrative Department from time to time.
5. That the Physical/Financial achievements along with Statement of Expenditure & Utilization Certificate are to be sent to the State Health Society.
6. That all the structure/buildings/equipment/vehicles supported under NHM should prominently display Logo of NHM in English, Hindi and regional languages.
7. That the proper record of Bank Column Cash Book, Ledger, Assets and other relevant record is to be maintained at all levels for check of any visiting team Central/State Govt. team.

That the accounts of grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Officer of the Ministry of Health & Family Welfare, Government of India, whenever the society is called upon to do so.
