

The Grants-in-aid is released subject to the following conditions:

1. That the sanctioned funds are exclusively meant for payment of Incentive @ 5% on consolidated remuneration on monthly basis *w.e.f. April 2020 to December 2020* in favour of contractual manpower engaged under NHM (including NUHM) strictly as per terms & conditions mentioned in the enclosed Order No.95 of 2020 dated 11/11/, after adhering to various guidelines issued by the MoH&FW, GoI and observing all codal formalities required under rules.
2. That no diversion of funds shall be made without approval of competent authority.
3. That the funds shall be utilized for the purpose for which it has been sanctioned and also ensure that there may not be duplication of similar activities from other source.
4. That the Health Institution/District Health Society shall accept the funds on PFMS portal after confirming the same from their bank accounts and subsequently release funds to the concerned through the same portal/e- transfer under intimation to the State Health Society, NHM, J&K. Further, Health Institution/District shall also ensure that all the expenditure have to be uploaded on PFMS portal and implement the EAT module of PFMS.
5. That the timely submission of Concurrent Audit Report & compliance to the observations made in the Statutory Audit Report.
6. That the Physical/Financial achievements (MPR/FMR) are to be sent to the State Health Society on regular basis.
7. That the proper record of Bank Column Cash Books, Ledgers, Assets created, complete address of beneficiaries and other relevant records are to be maintained at all levels strictly as per the financial guidelines by MoH&FW, GoI.
8. That the accounts of the grantee shall be open to inspection by the sanctioning authority and Audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by Principal Accounts Officer of the Ministry of Health & Family Welfare, GoI. Whenever the society is called upon to do so.

Dated 11-11-2020


Sanction is hereby accorded to the payment of incentives on consolidated remuneration, in favour of all the contractual manpower engaged under NHM in the Union Territory of Jammu & Kashmir.

The incentive is sanctioned for boosting the morale of the contractual manpower engaged under NHM who are the frontline worker and have put their services dedicatedly. The incentives shall be governed under the provisions of 'COVID-19 Emergency Response and Health System Preparedness Package' of the Ministry of Health & Family Welfare, Govt. of India.

Terms & conditions:

- 1) The payment of incentive shall be calculated on monthly basis @ 5 percent on consolidated remuneration starting from April 2020 to December 2020 for contractual manpower engaged under NHM;
- 2) Incentive shall be allowed for the specified period and shall not form the part of monthly remuneration for future payment; and
- 3) All payments under this order will be rounded off to the nearest rupee.
