In this connection it is to inform also, that One question in Paper of Staff Nurse has proved wrong after assessed by the experts in line with the result that question has been dropped, and as such 59 questions have been considered instead of 60 questions, having 60 marks and accordingly list of the shortlist candidates have been prepared.

If any candidate feels aggrieved with respect to non-inclusion/rejection of his/her name in the shortlist of candidate/s for interview, he/she may represent before the District Health Society along with the proof of documents within a period of **Two Days (02)** from the date of issuance of this notice. No claim of whatsoever kind shall be entertained after expiry of the notice period.

**The candidature of all the candidates is purely provisional.**

Only eligible candidates possessing requisite qualification prescribed under rules shall be allowed to appear in the interview subject to the conditions that they are within the prescribed age limit on the cut of date.

*The candidates shall produce their original certificates/testimonials on the date of interview. The Interviews will start from 10 am onwards. Shortlisted candidates are asked to report at 09:00 am. No candidate shall be allowed to appear in the Interview if unable to produce original Documents/Testimonials on the date of Interview.*
